**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

**Project Title:** Ptashne Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0131-R1)

**Project Location:** The project to be completed is located within the South Fork Eel River watershed, approximately 4.5 miles east of the town of Myers Flat, County of Humboldt, State of California. The project is located in Section 25, T2S, R3E, Humboldt Base and Meridian; in the Harris U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number: 211-372-007.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0131-R1, pursuant to Section 1602 of the Fish and Game Code to Josh Ptashne. The project consists of seven (7) encroachment(s). The project is limited to seven encroachments (Table 1). Seven proposed encroachments are to upgrade failing and undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts or rock, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.
