Project Title: Whittington Water Diversion and Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2018-0555-R1)

Project Location: The project to be completed is located within the Eel River watershed, approximately 5.5 miles NE of the town of Miranda, County of Humboldt, State of California. The project is located in Section 21, T02S, R04E, Humboldt Base and Meridian; in the Blocksburg U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Numbers 217-091-016 and 217-091-018; latitude 40.28018 and longitude -123.74238 W at the point of diversion.

Project Description: The project is limited to two encroachments. One encroachment is for water diversion from unnamed tributaries to the Eel River. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The other proposed encroachment is for removal of a failing stream crossing and restoration of the stream channel.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
