**Project Title:** Stamm Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0148-R1)

**Project Location:** The project is located approximately two miles North of the Town of Honeydew; affecting unnamed tributaries to the Mattole River in the County of Humboldt, State of California; Section 32, Township 2S, Range 1E; Humboldt Base and Meridian, in the Bull Creek, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map; Assessor's Parcel Number: 107-055-005.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number 1600-2019-0148-R1, pursuant to Section 1602 of the Fish and Game Code to Sean Stamm. The project consists of 3 encroachment(s): One encroachment is to decommission a water diversion from an Unnamed Tributary to Dry Creek. Work will include removal of diversion infrastructure. One encroachment is to replace an undersized culvert. Work will include excavation, removal of an existing undersized culvert, replacement with a properly sized culvert, backfilling, compaction of fill, and rock armoring to prevent erosion. One encroachment is for rock armoring the channel, both upstream and downstream of a culvert. Work for this encroachment will include maintenance of the crossing infrastructure.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.  
CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
