Project Title: Donald Ogden Water Diversion Project 1 Encroachment (Lake or Streambed Alteration Agreement No. 1600-2019-0664-R1), Assessor's Parcel Number 220-191-022

Project Location (include county): The project to be completed is located within the Mattole River watershed, approximately 19 miles Southwest of the town of Thorn Junction, County of Humboldt, State of California. The project is located in Section 33, T4S, R2E, Humboldt Base and Meridian; in the Briceland U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 220-191-022; latitude 40.0622 N and longitude -123.9654 W at the point of diversion (POD).

Project Description: The project is limited to 1 encroachment. One encroachment is for water diversion from Mattole River located on APN 220-191-019 to be stored and used on APN 220-191-022. Water is diverted for domestic and irrigation use. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
