Project Title: One Drop Cultivators Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0542-R1)

Project Location: The project is located approximately 2.5 miles southwest of the town of Phillipsville; affecting unnamed tributaries and Coon Creek, tributary to the South Fork Eel River in the County of Humboldt, State of California; Section 22, Township T3S, Range R3E; Humboldt Base and Meridian, in the Miranda, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map.

Project Description: The project consists of three encroachment(s): stream crossings will be appropriately upgraded and maintained to meet standards protective of fish and wildlife.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
