Project Title: Moffitt Stream Crossings Remediation Project (Lake or Streambed Alteration Agreement No. 1600-2019-0662-R1)

Project Location (include county): The project to be completed is located within the Mule and Butte Creek watersheds, approximately 6.7 miles southeast of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 25, T1N, R4E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-072-009; latitude 40.4347 N and longitude 123.6820 W.

Project Description: The project is limited to seven encroachments. The seven proposed encroachments are to upgrade existing road/stream crossings. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
