Project Title: Oliver Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0022-R1)

Project Location: The project to be completed is located within the Mad River watershed, approximately 2 miles NE of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 35, T02N, R05E, Humboldt Base and Meridian; in the Blake Mountain U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 208-231-003; latitude 40.5059 N and longitude 123.5755 W at the point of diversion.

Project Description: The project is limited to three encroachments. One encroachment is for water diversion from unnamed tributaries to the Mad River. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The second proposed encroachment is to upgrade an undersized culvert spillway on an on-stream pond. Water is not diverted from the on-stream pond. The pond will be inspected by a licensed engineer to determine if the construction meets Humboldt County building codes and to determine if the embankment and spillway are appropriately designed. The third proposed encroachment is to upgrade an undersized culvert on a road stream crossing. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).

CDFW's record related to the Lake or Streambed Alteration Agreement is available to the public for review at CDFW's regional office.
