Project Title: Aquarian-Heymann Pond and Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2019-0948-R1)

Project Location (include county): The project to be completed is located within the Chamise Creek watershed, approximately 12.2 miles southeast of the town of Garberville, County of Humboldt, State of California. The project is located in Section 14, T5S, R5E, Humboldt Base and Meridian; in the Jewett Rock U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 218-101-007; latitude 40.0286 N and longitude 123.5839 W.

Project Description: The project is limited to two encroachments. One proposed encroachment is to upgrade a failed culvert. The second proposed encroachment will improve a pond spillway. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
