Project Title: Preciado Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2019-0023-R1)

Project Location (include county): The project to be completed is located within the Fish Creek watershed, approximately 3 miles east of the town of Miranda, County of Humboldt, State of California. The project is located in Section 6, T3S, R4E, Humboldt Base and Meridian; in the Miranda U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 214-114-010.

Project Description: The project is limited to 3 encroachments. These encroachments include upgrading failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
