Project Title: Marinova Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0906-R1)

Project Location (include county): The project is located within the Salmon Creek watershed, approximately four miles southwest of the town of Miranda, County of Humboldt, State of California. The project is located in Section 7, T3S, R3E, Humboldt Base and Meridian; in the Ettersberg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 212-301-013.

Project Description: The project is limited to three encroachments to improve failing and undersized stream crossings. Work for two of these encroachments will include excavation, removal of the failing crossings, replacement with new properly designed crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. The third encroachment will decommission a stream crossing and adjacent road segment, relocate three existing structures encroaching the stream near the crossing, and rehabilitate the stream channel and riparian area.
