**Project Title:** Carl Stream Crossings and Water Diversion Project (Lake or Streambed Alteration Agreement No. 1600-2017-0471-R1)

**Project Location (include county):** The project to be completed is located within the Salmon Creek watershed, approximately 5 miles southwest of the town of Miranda, County of Humboldt, State of California. The project is located in Section 25, T3S, R2E, Humboldt Base and Meridian; in the Ettersberg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Numbers 221-141-037 and 221-141-038 for the places of use and 221-141-027 at the point of diversion; latitude 40.1775 N and longitude 123.9010 W at the point of diversion (POD).

**Project Description:** The project is limited to three encroachments (Table 1). One encroachment is for water diversion from an unnamed tributary to Hacker Creek located on APN 221-141-027. Water is diverted for domestic use only. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment is a rain catchment reservoir that drains to Hacker Creek. One encroachment is a recently installed stream crossing and alteration of an unnamed, Class II tributary to Hacker Creek.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.  
CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
