**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

**Project Title:** Stoft Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2019-0507-R1)

**Project Location:** The project to be completed is located within the South Fork Eel River watershed, approximately 1.60 miles Southeast of the town of Harris, County of Humboldt, State of California. The project is located in Section 31, T04S, R05E, Humboldt Base and Meridian; in the Harris U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 216-083-003; latitude 40.06371606 N and longitude -123.6532192 W at the point of diversion.

**Project Description:** The project is limited to six encroachments (Table 1). One encroachment is for water diversion from unnamed tributaries to Jewett Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. Another encroachment is for a proposed pond with an overflow that may connect to an adjacent stream during major storm events. Another encroachment is for decommissioning of an on-stream pond and restoration of the stream channel. The last three proposed encroachments are to upgrade or decommission failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings (or stream restoration), backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.  
CDFW considered the  mitigated negative declaration /  negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
