Project Title: Healy Water Diversion and Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2018-0058-R1)

Project Location: The project to be completed is located within the South Fork Trinity River watershed, approximately 5.5 air miles south of the town of Willow Creek, County of Humboldt, State of California. The project is located in Section 33, T06N, R05E, Humboldt Base and Meridian; in the Hennessy Peak and Grouse Mountain U.S. Geological Survey 7.5-minute quadrangles; Humboldt County Assessor's Parcel Numbers 524-124-001 and 524-125-001; latitude 40.8598 N and longitude 123.6239 W at the first point of diversion (POD).

Project Description: The project is limited to four encroachments. Two encroachments are for water diversion from unnamed tributaries to Old Campbell Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One encroachment is for decommissioning a prior water diversion from unnamed tributaries to Old Campbell Creek. The fourth proposed encroachment is to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
