Project Title: Miller Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2020-0208-R1)

Project Location: The project is located within the Mule Creek watershed, approximately 10 miles southeast of the town of Bridgeville, County of Humboldt, State of California; Section 25 and 26, T1N, R4E, Humboldt Base and Meridian, in the Larabee U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-071-011; latitude 40.4288 N and longitude -123.6941 W at the first point of diversion.

Project Description: The project is limited to 6 encroachments. One encroachment is for water diversion from an unnamed tributary to Mule Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The 5 other proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
