**Project Title:** Cochran Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2020-0349-R1)

**Project Location (include county):** The project to be completed is located within the Burr creek and Van Duzen River watersheds, approximately 2.5 miles southwest of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 17, T1N, R5E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-231-003; latitude 40.4671 N and longitude 123.6376 W at the point of diversion (POD).

**Project Description:** The project is limited to three encroachments. One encroachment is for water diversion from Burr Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The two other proposed encroachments are to upgrade existing road/stream crossings. Work for these encroachments will include excavation, removal of one culvert, installation with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
