Project Title: Muennink Stream Crossings and Diversion (Lake or Streambed Alteration Agreement No. EPIMS-HUM-03781-R1)


Project Location (include county): The project to be completed is located within the Eel River watershed, approximately 12 miles east of the town of Garberville, County of Humboldt, State of California. The project at 25 Sesame Loop, Garberville; Assessor's Parcel Number 218-141-001-000 latitude 40.04445 N and longitude 123.560218 W the center of the parcel.

Project Description The project is limited to 6 encroachments. Four encroachments are to upgrade undersized culverts. Work for these encroachments will include excavation, removal of the culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. One encroachment is to install rock dissipation at the outlet of a properly sized culvert. The other encroachment is for a water diversion to install a concrete cistern and operate the diversion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
 CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
