Project Title: Sandoval Uriarte Wilder Ridge Connection Stream Crossings Project
(Lake or Streambed Alteration Agreement No. 1600-2020-0379-R1)

Project Location (include county): The project is located within the Mattole River watershed, approximately 3.9 miles Southeast of the town of Honeydew, County of Humboldt, State of California; Section 20, T3S, R1E, Humboldt Base and Meridian, in the Honeydew U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 108-261-014; latitude 40.1893 N and longitude 124.0954 W at the first stream crossing.

Project Description: The project is limited to three encroachments (Table 1). One encroachment is to perform maintenance and armoring of an obstructed stream crossing; if the existing culvert is damaged or dysfunctional, Permittee shall reconstruct the crossing with a new culvert. The other encroachments are to decommission two crossings on a disused road. Work for these encroachments will include excavation, removal of fill material, excavation and contouring to recreate the original channel grade and orientation, and rock armoring and revegetation as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
6. Findings were not made by CDFW pursuant to Public Resources Code section 21081, subdivision (a).
