**Project Location:** The project to be completed is located within the Mattole River watershed, approximately 11 miles east of the town of Miranda, County of Humboldt, State of California. The project is located in Section 3, T03S, R1E, Humboldt Base and Meridian; in the Honeydew U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 107-111-021; latitude 40.23450 N and longitude -124.04790 W at stream crossing 1.

**Project Description:** The project consists of 1 encroachment: The project is limited to 1 encroachment (Table 1). One encroachment for a stream crossing on an unnamed tributary to Middle Creek. The proposed encroachment is to upgrade failing and undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, rock armoring as necessary to minimize erosion, and maintenance of culverts.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
