**Project Title:** Gradin Stream Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2019-0302-R1)

**Project Location:** The project to be completed is located within the Trinity River watershed, approximately 10.5 miles S/SE of the town of Willow Creek, County of Humboldt, State of California. The project is located in Section 25, T05N, R04E, Humboldt Base and Meridian; in the Grouse Mountain U.S. Geological Survey 7.5-minute quadrangle; Humboldt County Assessor's Parcel Number 316-012-013; latitude 40.7908 N and longitude 123.6735 W at the stream crossing.

**Project Description:** The project is limited to one encroachment. The encroachment is for maintenance of a stream crossing. Work for this encroachment will monitoring and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
