Project Title: Perry Water Diversion, Pond, and Stream Crossings Project (Lake or Streambed Alteration Agreement No. 1600-2020-0159-R1)

Project Location (include county): The project to be completed is located within the Salmon Creek watershed, approximately 5.7 miles west of the town of Miranda, County of Humboldt, State of California. The project is located in Section 3, T3S, R2E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 221-021-008; latitude 40.232 N and longitude 123.937 W.

Project Description: The project is limited to four encroachments. One encroachment is for water diversion from a hydrologically connected pond, which is located on an unnamed tributary to Salmon Creek. Water is diverted for irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. Three additional projects are proposed to improve stream crossings. Work for these encroachments will include excavation, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
