Project Title: O'Connor Water Diversions and Stream Crossings (Lake or Streambed Alteration Agreement No. EPIMS-04191-R1)

Project Location (include county): The project to be completed is located within the Lower Eel watershed approximately 9 miles east of the town of Garberville, County of Humboldt, State of California. The project is located on Assessor's Parcel 216-142-014; latitude 40.142478 N and longitude 123.68499 W.

Project Description The project is limited to 12 encroachments. Two encroachments are for existing surface water diversions on Class II watercourses, two encroachments will repair erosion on a legacy road by reducing the bank slope and adding rip-rap, one encroachment will repair bank failure downstream from a rock ford with rolling dips/waterbars, two encroachment will lessen diversion potential on an armored fill and rock crossings by accentuating existing dips and adding rock armoring, and 5 encroachments are to upgrade failing or undersized culverts. Work for these encroachments will include excavation, removal of the failing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
