Project Title: Perkins Water Diversion, Onstream Pond, and Crossing Project (Lake or Streambed Alteration Agreement No. 1600-2019-0230-R1)

Project Location (include county): The project is located within the Eel River watershed, approximately 5.6 miles South and East of the town of Harris, County of Humboldt, State of California; Assessor's Parcel Number (APN) 218-141-006. The first point of diversion (POD) is located off parcel to the North on APN 218-141-009 at latitude 40.0443 N and longitude -123.5677 W. The parcel was not fully evaluated by CDFW, and only the POD-1 project is covered under this Agreement.

Project Description: The project consists of 4 encroachments: The project is limited to 4 encroachments. Two encroachments are for water diversion from unnamed tributaries to Chamise Creek. Water is diverted for domestic use and irrigation. No water rights on file in eWRIMS as of the date this permit was provided. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The two other proposed encroachments are to upgrade failing and undersized stream crossings, upgrade spillways for an onstream pond. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
