Project Description: Culvert Replacement. The project is limited to the replacement of two undersized culverts with one 36" culvert, requiring the excavation and temporary displacement of soil 16-feet long x 6-feet wide x 5-feet deep, as well as the installation of headwalls and/or rock slope protection. After placing the new culvert, all removed sediment will be backfilled, compacted, and returned to its preexisting grade.

Temporary Water Diversion.
