**SUBJECT: Filing of Notice of Determination pursuant to Public Resources Code section 21108**

**Project Title:** Maui 84' Water Diversion and Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-15925-HUM-R1)

**Project Location (include county):** The project is located within the Lower Eel River watershed, approximately 12.7 miles south east of the town of Bridgeville, County of Humboldt, State of California; Assessor's Parcel Number 210-144-014 and 210-144-015; latitude 40.4053 N and longitude -123.5825 W at the first point of diversion.

**Project Description:** The project is limited to 9 encroachments. Four encroachments are for water diversion from unnamed tributaries to Dairy and Panther Creeks. Water is diverted for irrigation. Work for the water diversion will include use, maintenance, and upgrading for POD's 1-4. Work removing old infrastructure by hand or tools will be conducted to restore the springs to natural conditions. The 5 other proposed encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
