**Project Title:** O'Connor Stream Crossings and Pond Restoration Project (Lake or Streambed Alteration Agreement No. 1600-2018-0415-R1)

**Project Location:** The project is located within the Jacoby Creek watershed, approximately 5.8 miles SE of the town of Arcata, County of Humboldt, State of California; Assessor's Parcel Numbers 404-111-008 and 404-111-013 ; latitude 40.8079 N and longitude 124.0109 W at the first stream crossing.

**Project Description:** The project is limited to seven encroachments (Table 1). Five encroachments are to upgrade failing and undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. One encroachment is to decommission prior stream modifications and restore the stream channel or repair and maintain existing onstream dam for recreational and aesthetic purposes. Work on the dam will include a geologic setting report, slope and dam stability report, bypass design plans, and spillway design plans.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
