Project Title: Kaiser LSAA, APN 316-191-018 Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-15681-R1C)

Project Location: The project is located approximately 10 miles southwest of the Town of Willow Creek; affecting unnamed tributaries to Redwood Creek in the County of Humboldt, State of California; Section 6, Township 5N, Range 4E; Humboldt Base and Meridian, in the Maple Creek, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map; Assessor's Parcel Number: 316-191-018.

Project Description: The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-15681-R1C, pursuant to Section 1602 of the Fish and Game Code to James Kaiser. The project consists of three (3) encroachment(s): One encroachment is for water diversion from an unnamed tributary to Redwood Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include facility retrofit, use, and maintenance. Two encroachments are to upgrade undersized culvert stream crossings. Work for these encroachment(s) will include excavation, culvert replacement, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
