Project Title: Sadosky Stream Crossings Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-16148-R1C)

Project Location: The project is located within the Ohman Creek watershed, approximately one (1) mile southwest of the town of Garberville, County of Humboldt, State of California; Section 23, T04S, R03E, Humboldt Base and Meridian, in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 222-156-015-000; latitude 40.0933 N and longitude -123.8136 W at the first stream crossing.

Project Description: The project is limited to two (2) encroachments. Both encroachments are to upgrade failing or undersized stream crossings. Work for these encroachments will include excavation, removal of the failing crossings, replacement with new properly sized crossings, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion. Work for the culvert replacements shall be completed by no later than October 15, 2022.
