**Project Title:** Winkle Stream Crossing Project (Streambed Alteration Agreement No. EPIMS-HUM-26051-R1C)

**Project Location:** The project to be completed is located within the Little Larabee Creek watershed, approximately 4.3 miles east southeast of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 22, T01N, R04E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-044-008; latitude 40.4552 N and longitude 123.7043 W at the first stream crossing.

**Project Description:** The project is limited to two encroachments to upgrade existing stream crossings. Work for these encroachments will include excavation of the existing natural ford crossing, installation of new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

**Determination:** This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
