Project Title: Troyer Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-29124-R1C)

Project Location (include county): The project to be completed is located within the Pine Creek watershed, approximately seven miles southwest of the town of Hoopa, County of Humboldt, State of California. The project is located in Section 13, T7N, R3E, Humboldt Base and Meridian; in the Lord Ellis Summit U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 521-123-005; latitude 40.9929 N and longitude 123.7831 W at the point of diversion (POD).

Project Description: The project is limited to one encroachment for water diversion from an unnamed spring tributary to Pine Creek. Water is diverted to storage for irrigation. Work for the water diversion will include upgrades to the water diversion infrastructure and remediation of the downstream channel to promote unimpeded bypass flow.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
