Project Title: Saunders Water Diversion and Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-28933-R1C)

Project Location (include county): The project to be completed is located within the Bear Creek and Mad River watersheds, approximately 1.5 miles northeast of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 35, T02N, R05E, Humboldt Base and Meridian; in the Blake Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-231-015-000; latitude 40.5027 N and longitude 123.5800 W at the point of diversion (POD).

Project Description: The project is limited to five encroachments. One encroachment is for water diversion from Mad River. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The four other proposed encroachments are to upgrade existing culverts at road/stream crossings. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
4. A mitigation reporting or monitoring plan was / was not adopted by CDFW for this project.
5. A Statement of Overriding Considerations was not adopted by CDFW for this project.
