Project Title: Harte Stream Crossings Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-25781-R1)

Project Location (include county): The project to be completed is located within the Mill Creek watershed, approximately three miles east of the town of Dinsmore, County of Humboldt, State of California. The project is located in Section 12, T01N, R05E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-331-009-000; latitude 40.4752 N and longitude 123.5526 W at the first stream crossing.

Project Description: The project is limited to eight (8) encroachments. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
