**Project Title:** Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-33727-R1C)

**Project Location (include county):** The project to be completed is location within the Canoe Creek – South Fork Eel River watershed, approximately 3.3 miles northeast of the town of Myers Flat, County of Humboldt, State of California. The project is located in Section 15, T02S, R03E, Humboldt Base and Meridian; in the Myers Flat U.S. Geological Survey 7.5-minute quadrangle; Assessor’s Parcel Number 211-331-042-000; latitude 40.2965 N and longitude 123. 8277 W at the stream crossing.

**Project Description:** The project is limited to one encroachment. The proposed encroachment is to upgrade an existing culvert and removal of abandoned POD infrastructure. Work for this encroachment will include excavation, removal of the existing culvert, replacement with new properly sized culvert, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
