Project Title: Sherr Water Diversion and Stream Crossings Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-15774-R1C)

Project Location (include county): The Project to be completed is located within the Pipe Creek – Eel River watersheds, approximately 11 miles southeast of the town of Garberville, County of Humboldt, State of California. The Project is located in Section 10, T05S, R05E, Humboldt Base and Meridian; in the Jewett Rock U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 218-071-005-000; latitude 40.0320 N and longitude 123.6072 W at the point of diversion (POD).

Project Description: The Project is limited to six encroachments. One encroachment is for water diversion from a horizontal pipe set into the hillside. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure. One proposed encroachment is for the improvement of a pond spillway. The four other proposed encroachments are to upgrade existing culverts or unimproved crossings. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
