Project Title: Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-35236-R1C)


Project Location (include county): The project to be completed is located within the Fish Creek – South Fork Eel River watershed, approximately 1 mile southwest of the town of Benbow, County of Humboldt, State of California. The project is located in Section 6, T05S, R04E, Humboldt Base and Meridian; in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor’s Parcel Number 033-140-008; latitude 40.0609 N and longitude 123.7694 W at the stream crossing.

Project Description: The project is limited to one encroachment. Work for this encroachment will include rock armoring the outlet as necessary to minimize erosion.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
