Project Title: Water Diversion (Lake or Streambed Alteration Agreement No. EPIMS-HUM-30682-R1C)

Project Location (include county): The project to be completed is located within the Mattole River watershed, approximately 1.1 miles northeast of the town of Petrolia, County of Humboldt, State of California. The project is located in Section 2, T02S, R02W, Humboldt Base and Meridian; in the Petrolia U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 105-101-014-000; latitude 40.3262 N and longitude 124.2712 W at the point of diversion (POD).

Project Description: The project is limited to one encroachment. The single encroachment is for water diversion from an unnamed tributary to Mill Creek. Water is diverted for domestic use only. Work for the water diversion will include use and maintenance of the water diversion infrastructure. The Permittee has also enclosed a rainwater catchment pond used for irrigation purposes.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
