Project Title: Water Diversion (Lake or Streambed Alteration Agreement No. EPIMS-HUM-41835-R1C)

Project Location (include county): The Project to be completed is located within the Honeydew Creek watershed, approximately 4.2 miles south of the town of Honeydew, County of Humboldt, State of California. The Project is located in Section 20, T03S, R01E, Humboldt Base and Meridian; in the Honeydew U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 107-261-021-000 at the Place of Use (POU) and 107-261-014-000 at the Place of Diversion (POD); latitude 40.1899 N and longitude 124.0974 W at the point of diversion (POD).

Project Description: The Project is limited to one encroachment. The encroachment is for water diversion from an unnamed tributary to East Fork Honeydew Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure.
