Project Title: Stream Remediation (Lake or Streambed Alteration Agreement No. EPIMS-HUM-34614-R1C)

Project Location (include county): The Project to be completed is located within the Bear Creek - Mad River watershed, approximately ¼ mile east of the town of Mad River, County of Humboldt, State of California. The Project is located in Section 21, T01N, R06E, Humboldt Base and Meridian; in the Dinsmore U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 018-580-013-000; latitude 40.4518 N and longitude 123.5058 W at the stream crossing remediation location.

Project Description: The Project is limited to one encroachment. The single encroachment is to cut off the exposed section of a shallow well (down to channel bed), backfill with clean rock and gravels, and remove associated electrical box, post, wires, and water lines.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
