**Project Title:** Arcuri Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-45772-R1)

**Project Location (include county):** The Project to be completed is located within the Eel River watershed, approximately 5 miles southwest of the community of Miranda, County of Humboldt, State of California. The Project is located in Section 13, T03 south, R02 east, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number (APN) 219-011-004; latitude 40.2049 and longitude - 123.9060 at the point of diversion (POD) for use on APN 219-011-009.

**Project Description:** The Project is limited to one encroachment. The encroachment is for water diversion from an unnamed tributary to South Fork Salmon Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure.
