Project Title: Sordal Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-45317-R1)

Project Location (include county): The project to be completed is located within the Mule and Butte Creek watersheds, approximately 6.7 miles southeast of the town of Bridgeville, County of Humboldt, State of California. The project is located in Section 25, T1N, R4E, Humboldt Base and Meridian; in the Larabee Valley U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 210-072-009-000; latitude 40.4355 N and longitude 123.6730 W at stream crossing.

Project Description: The project is limited to one encroachment. The single encroachment will upgrade a culvert at a road/stream crossing. Work for this encroachment will include extending the culvert a minimum of 4 feet to extend beyond the road fill at the outlet, and rock armoring as necessary to minimize erosion.
