Project Title: Water Diversion (Lake or Streambed Alteration Agreement No. EPIMS-HUM-46169-R1C)

Project Location (include county): The Project to be completed is located within the Bear Creek watershed, approximately 2.5 miles northwest of the town of Dinsmore, County of Humboldt, State of California. The Project is located in Section 31, T02N, R05E, Humboldt Base and Meridian; in the Showers Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-271-004-000; latitude 40.5144 N and longitude 123.6464 W at the point of diversion (POD).

Project Description: The Project is limited to one encroachment. The single encroachment is for water diversion from a spring, tributary to Mad River. Water is diverted for domestic use and irrigation. Work for the water diversion will include modification or replacement, use, and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):
