Project Title: Water Diversion (Lake or Streambed Alteration Agreement No. EPIMS-HUM-40983-R1C)

Project Location (include county): The Project to be completed is located within the Upper Mattole River watershed, approximately 8.5 miles southeast of the town of Honeydew, County of Humboldt, State of California. The Project is located in Section 17, T03S, R02E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 221-101-012-000; latitude 40.2022 N and longitude 123.9713 W at the point of diversion (POD).

Project Description: The Project is limited to one encroachment. The single encroachments is for water diversion from a spring unnamed tributary to Mattole River. Water is diverted for domestic use and irrigation. Work for the water diversion will include modification, use, and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
