Project Title: Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-49371-R1C)

Project Location (include county): The Project to be completed is located within the Ohman Creek – South Fork Eel River watershed, approximately 2.2 miles northeast of the town of Garberville, County of Humboldt, State of California. The Project is located in Section 8, T04S, R04E, Humboldt Base and Meridian; in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor’s Parcel Number (APN) 223-261-005-000 (POU); 223-291-003-000 (POD); latitude 40.1218 N and longitude 123.7609 W at the point of diversion (POD).

Project Description: The Project is limited to one encroachment for water diversion from an unnamed tributary to Dean Creek. Water is diverted for domestic use. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
