Project Title: Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-47561-R1C)

Project Location (include county): The Project to be completed is located within the Lower Mattole River watershed, approximately 3.5 miles southeast of the town of Petrolia, County of Humboldt, State of California. The Project is located in Section 24, T02S, R02W, Humboldt Base and Meridian; in the Petrolia U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 104-121-002-000 (POU); 105-131-001-000 (POD); latitude 40.2808 N and longitude 124.2527 W at the point of diversion (POD).

Project Description: The Project is limited to one encroachment for water diversion from an unnamed tributary to Mattole River. Water is diverted for domestic use and irrigation. Work for the water diversion will include replacement, use, and maintenance of the water diversion infrastructure. The current infrastructure shall be removed and replaced with infrastructure meeting the terms set forth in this Agreement. Only hand tools may be used in the removal of the infrastructure. The rock dam shall be removed or altered to ensure consistent 80% bypass at all times.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
