Project Title: Water Diversion, Stream Crossings, and Pond Spillway Armoring Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-35067-R1C)

Project Location (include county): The Project to be completed is located within the Upper Larabee Creek watershed, approximately 10.8 miles northeast of the town of Miranda, County of Humboldt, State of California. The Project is located in Section 17, T02S, R05E, Humboldt Base and Meridian; in the Blocksburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 217-255-005-000; latitude 40.2974 N and longitude 123.6332 W at the point of diversion (POD).

Project Description: The Project is limited to four encroachments. One encroachment is for water diversion from Mountain Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include installation, use, and maintenance of the water diversion infrastructure. One proposed encroachment is for the armoring of a pond spillway. Additional rock armoring shall be placed to minimize erosion and stabilize the channel. Two other proposed encroachments are to upgrade or repair existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
