Project Title: Damron Water Diversion Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-33177-R1)

Project Location: The project to be completed is located within the Trinity River watershed, approximately 2.7 miles west of the town of Willow Creek, County of Humboldt, State of California. The project is located in Assessor's Parcel Number 522-044-068; latitude 40.9354 N and longitude 123.6872 W at the first point of diversion (POD).

Project Description: The project is limited to two encroachments for water diversion from springs of unnamed tributaries to Willow Creek. Water is diverted for domestic use and irrigation. Work for the water diversion will include use and maintenance of the water diversion infrastructure.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
