**Project Title:** POD removal Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-53261-R1C)

**Project Location:** The project is located approximately 5.5 miles south of the town of Willow Creek; affecting two unnamed tributaries to South Fork Trinity River in the County of Humboldt, State of California; Section 27, Township 6N, Range 5W; Humboldt Base and Meridian, in the Hennessy Peak, Calif. 7.5-minute quadrangle, U.S. Geological Survey (USGS) map; Assessor's Parcel Number: 524-112-002.

**Project Description:** The California Department of Fish and Wildlife has executed Lake and Streambed Alteration Agreement number EPIMS-HUM-53261-R1C, pursuant to Section 1602 of the Fish and Game Code to Craig Maclay. The project consists of two encroachment(s): The two encroachments are for the removal of water diversion infrastructure from two unnamed tributaries to the South Fork Trinity River. Work will include the removal of two water diversions and restoring the stream channel to its natural configuration. Clean, washed rock shall be used to backfill the removal as necessary.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
