**Project Title:** Water Diversion and Stream Crossing Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-50229-R1C)

**Project Location:** The Project to be completed is located within the Bear Creek - Mad River watershed, approximately 1.45 miles northwest of the town of Dinsmore, County of Humboldt, State of California. The Project is located in Section 33, T02N, R05E, Humboldt Base and Meridian; in the Blake Mountain U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 208-251-008-000; latitude 40.5094 N and longitude 123.6224 W at the point of diversion (POD).

**Project Description:** The Project is limited to two encroachments. One encroachment is for water diversion from a spring, tributary to Mad River. Water is diverted for irrigation use only. Work for the water diversion will include removal and replacement, use, and maintenance of the water diversion infrastructure. The other proposed encroachment is to upgrade an existing culvert. Work for this encroachment will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency, approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A  mitigated negative declaration /  negative declaration was prepared for this project pursuant to the provisions of CEQA.
