Project Title: Water Diversion and Revegetation and Restocking Plan (Lake or Streambed Alteration Agreement No. EPIMS-HUM-54004-R1C)

Project Location (include county): The Project to be completed is located within the Upper Mattole River watershed, approximately 6.8 miles west of the town of Redway, County of Humboldt, State of California. The Project is located in Section 9, T04S, R02E, Humboldt Base and Meridian; in the Ettersburg U.S. Geological Survey 7.5-minute quadrangle; Assessor's Parcel Number 221-221-016-000; latitude 40.1318 N and longitude 123.9622 W at the point of diversion (POD).

Project Description: The Project is limited to two encroachments. One encroachment is for water diversion from Blue Slide Creek. Water is diverted for domestic use only. Work for the water diversion will include annual installation and removal, use, and maintenance of the water diversion infrastructure. The other proposed encroachment is to revegetate and restock two locations totaling approximately 48,750 ft2 and along 325 feet of stream to restore native riparian vegetation lost through unauthorized activities.

This is to advise that CDFW, acting as the Lead Agency / a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW's permitting jurisdiction as a Responsible Agency.
2. A mitigated negative declaration / negative declaration was prepared for this project pursuant to the provisions of CEQA.
CDFW considered the mitigated negative declaration / negative declaration prepared by the Lead Agency for this project pursuant to California Code of Regulations section 15096, subdivision (f).
3. Mitigation measures were / were not made a condition of CDFW's approval of the project.
