**Project Title:** Stream Channel Restoration Project (Lake or Streambed Alteration Agreement No. EPIMS-HUM-54677-R1C)

**Project Location (include county):** The Project to be completed is located within the Fish Creek – South Fork Eel River watershed, approximately 5.9 miles southeast of the town of Garberville, County of Humboldt, State of California. The Project is located in Section 18, T05S, R04E, Humboldt Base and Meridian; in the Garberville U.S. Geological Survey 7.5-minute quadrangle; Assessor’s Parcel Number 223-045-002-000; latitude 40.0187 N and longitude 123.7633 W at the stream channel restoration.

**Project Description:** The Project is limited to one encroachment. The single encroachment is for a Class III stream channel restoration with culvert removal and armored fill installation. The stream is currently occupying several erosional features that are a result of previous logging and earthmoving activities. The erosional features shall be decommissioned, and the native channel reconnected to the stream a combination of culvert upgrading, armored fill installation, and daylighting of a segment of channel. Work for this encroachment will include excavation, removal of the existing culvert, replacement with new properly sized culvert, creation of a daylighted channel, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.

This is to advise that CDFW, acting as  the Lead Agency /  a Responsible Agency approved the above-described project and has made the following determinations regarding the project pursuant to California Code of Regulations section 15096, subdivision (i):

1. The project will not have a significant effect on the environment. This determination is limited to effects within CDFW’s permitting jurisdiction as a Responsible Agency.
