Project Title: Rappaport Stream Crossing Projects (Lake or Streambed Alteration Agreement No. EPIMS-HUM-57912-R1C)

Project Location (include county): The Project to be completed is located within the Campbell Creek – Trinity River watershed, approximately 1.84 miles southwest of the town of Willow Creek, County of Humboldt, State of California.

Project Description: The Project is limited to two encroachments. The two proposed encroachments are to upgrade or modify existing culverts. Work for these encroachments will include excavation, removal of the existing culverts, replacement with new properly sized culverts, backfilling and compaction of fill, and rock armoring as necessary to minimize erosion.
